

Target Talk On-Going Competition – Competition Terms and Conditions

1. Information on how to enter and prizes form part of these conditions. By participating, entrants agree to be bound by these conditions. Entries must comply with these conditions to be valid.
2. Entry is open to residents of Australia aged 18 years or over who are primarily or jointly responsible for the grocery shopping for their households and who receive an e-mail inviting them to participate in the Target Community Panel 'Target Talk' ("Panel") or who are existing members of the Panel and who receive an e-mail inviting them to re-register for the Panel ("Invitation email"). Directors, managers and employees and their immediate families of the Promoter and its agencies or other companies associated with this promotion are ineligible to enter. "Immediate families" include siblings, parents, children and family living in the same household.
3. To go into the draws for Monthly Rewards 1-12 (as outlined in Clause 5), entrants must, when invited to do so by the Promoter, fully complete an online research survey (other than the Registration survey) during the Promotional Period (as defined in Clause 5).
